### DAY 2: 20 NOV 2019 | AT SEA | CPD: 6 HRS

An opportunity to review and explore prior learning, experience and policies governing our Nursing careers. This session will gather your specific issues and matters to ensure these will be addressed throughout the conference.

### 0930 - 1030: What are the key areas of Law that can affect Nurses?

This session will define and explain common law, civil law, criminal law, statute law, coronial inquiries, employment law and professional indemnity insurance. Discussion will address how and when these might give rise to actions against a Nurse.

1030 - 1100: Break

### 1100 – 1200: Why we need to Understand the Tort of Negligence

Negligence has over the last two decades broadened to include claims of damage that were once outside the realms of the common law. At its core, the approach to determining if there is a case in negligence are the elements of negligence. This session will explain these concepts and discuss how, in practice the Nurse can use them in assessing a situation that carries risks.

1200 - 1330: Lunch

### 1330 – 1500: Applying Concepts of Negligence to real-world Experiences

This is an interactive session where participants can relate their own practice situations and explore how these might be interpreted against elements of negligence. Legal cases will be examined.

1500 - 1530: Break

1530 - 1630: Consent

Every Nurse believes they adhere to the rules but the law on consent is evolving and the obligations on health professionals have become broader and expectations about the informed consent have become higher.

1630 - 1700: Review and question session

### DAY 3: 21 NOV 2019 | AT SEA | CPD: 6 HRS

### 0830 - 0930: Fraudulent and criminal Nursing Actions

What makes something a crime and how both the legal and professional bodies respond to and sanction such behaviours will be discussed. We will consider the various legal regulatory strategies which may be used to control such conduct with a view to matching appropriate strategies with the various forms of dishonest conduct which may take place.

# 0930 – 1030: What are the legal, cultural requirements and Nursing Responsibilities after a Death?

For many Nurses it has been a long time since they were taught the procedures of caring for the deceased client. Over time the protocols for preparation have altered in line with requirements for autopsy, coronial and police investigations.

1030 - 1100: Break

### **1100 – 1200: Scope of Practice**

This session aims to clarify the professional and legal interpretation of Scope of Practice to ensure, as clinicians, we have the capacity to judge and relate real world situations to these boundaries and understand the consequences of failing to work within them.

### 1400 – 1530: Coronial Inquiries and Investigations

A perennial anxiety for Nurses is being called to provide information or be a witness at a Coroner's Inquest. The procedures and expectations of the system will be explained and the responsibilities of health professionals who may be involved will be discussed.

### 1530 - 1630: Professional Boundaries and Boundary Crossings

This session will explore the Code of Professional Conduct for Nurses and the concept of professional boundaries. Recognising just what constitutes transgressions and likely professional consequences will be the main focus.

0830 - 0930: Legal Cases that challenge Nursing

There are few cases but those that directly affected Nursing policies, Nursing education and Nursing practice are worth examining. Documentation, medication administration, discharge planning and management responsibilities will be among the issues raised.

# 0930 – 1030: Risk Management, Incident Reports and Defensive Documentation

The need for investigation into incidents is accepted. How to structure an incident report and the potential use of this document in legal proceedings has been controversial at times. However, these documents are used by lawyers so professional responsibility for generating these needs to be understood.

1030 - 1100: Break

### 1100 - 1200: Good Samaritan Law

The duty to rescue and obligations on the professional faced with an emergency cause anxiety and the fear of negative outcomes leading to legal liability inhibit and dismay. This session will discuss the legal and professional obligations and explore the law in relation to rescuers and the injured.

1200 - 1400: Lunch

### 1400 - 1530: The most common Nursing errors

While not all errors have legal consequences we all work hard to avoid mistakes. Research has shown not only the most likely errors but the circumstances that in **real world** situations give rise to them.

# 1530 - 1630: Professional Malpractice, Professional Misconduct, Unsatisfactory Conduct

This session will explore the law that governs Nurses, the systems that lead to investigations and the meaning of these labels. Cases and tribunal findings will be used to explore findings of negligence and conduct that have led to sanctions and penalties against Nurses.

1630 - 1700: Review and question session

### 28 NOV 2019 | AT SEA | CPD: 6 HRS

### 0830 - 0930: Dealing with Complaints

We are all familiar with conflict situations and aware if poorly handled these can move into legal and professional minefields. Strategies to defuse and respond to conflict are often learnt "on the job" but difficult situations are the norm for Nurses and understanding how our communication and approaches can resolve and avoid further actions can be valuable.

#### 0930 – 1030: Behaviours that open the way for Tort Actions

Habits of practice and habits of Nursing communication can underpin accusations of bullying, defamation, slander and libel. Issues of confidentiality and trespass to person are minefields in practice. Examples from the workplace will be used to guide discussion.

1030 - 1100: Break

### 1100 – 1200: Confusing Situations

Legislation and social attitudes are constantly changing. The rules governing certification of death, organ donation, chemical and physical restraints are some of the areas that can arise in our clinical situations and cause anxiety.

1200 - 1400: Lunch

### 1400 – 1530: Voluntary and Involuntary Admission

Legislation dictates just when and how consumers are admitted for mental health services. The rights of the client are paramount considerations but are often overlooked in general health services.

#### 1530 - 1630: 1530 – 1630: Oh no, not another Student to Supervise!

Many Nurses fear the consequences of student errors and their capacity to delegate and manage student work. The rules governing responsibility and risks are the focus of this session.
