#### Illicit Drug Use in Australia | Self-directed Webinar | Access via the online library

The use of Illicit drugs can result in health complications and, in some cases, fatalities. It affects the individual using the substances and has implications for their family, friends, and the wider community. This category encompasses the consumption of controlled substances, non-prescribed use of pharmaceuticals, and the use of other substances, like inhalants, in ways not intended by manufacturers.

#### Pill Testing - A harm reduction initiative | Self-directed Webinar | Access via the online library

While the benefits of pill testing are significant, there are also challenges and criticisms. Some argue that it could implicitly encourage drug use or convey a message that drug use can be made safe. Others point out logistical challenges, such as the accuracy of tests and the complexity of interpreting results for users. Despite these concerns, many health experts and harm reduction advocates continue to support pill testing as a practical approach to reducing the negative consequences of recreational drug use.
